Well... Okay then.



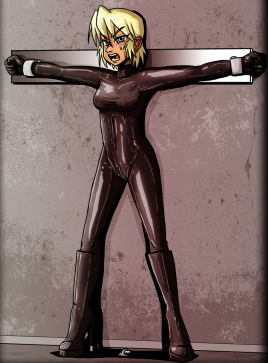
W-what the hell is this clothing?

ing.

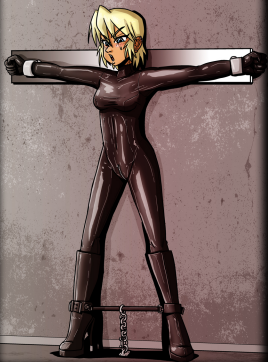




Hey! What is all this!?

What!? I never touched anyone!

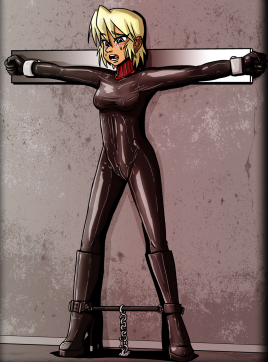


This might help you remember,

Maybe?

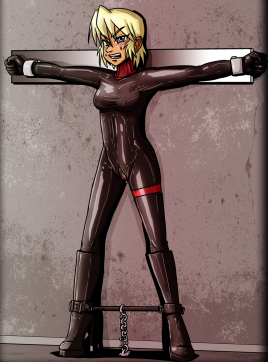


Aah... Something comes to mind...

nn... No, nothing...

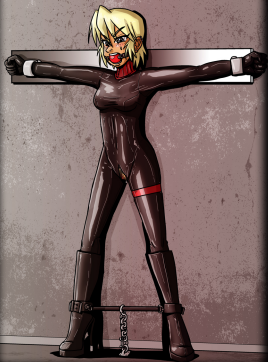
Let's continue to proceed.

Subject J-8N13, please try to repeat your memories from your actions with asset no. S-032X1.

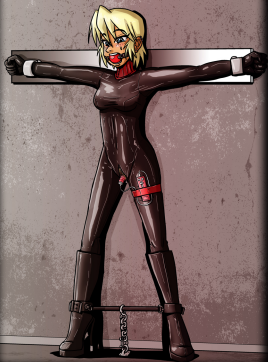
I... I still can't remember... come on! What is this all about?

032X1.

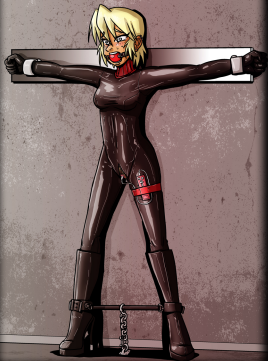
Aaaah... ah... hawaa...

Uush...

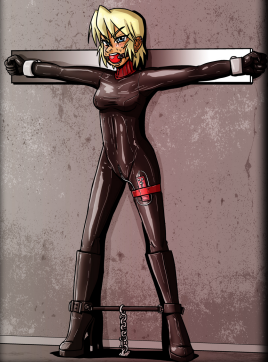


Uuuhn!

How does it feel?

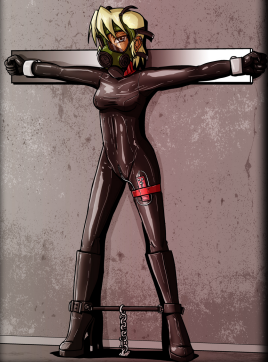

Hnnnf!



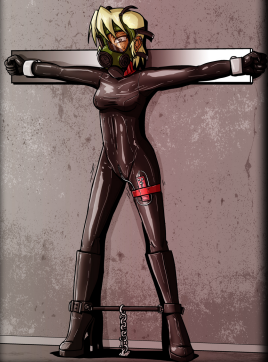


Hmuuuhpfff!

What was that Subject J-8N13? Is a unforeseen detail missing from the situation we are trying to simulate here?



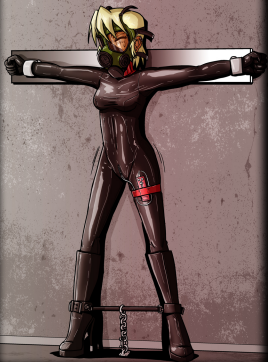
VRRRRWWWWWWW!!!

However, due to the serious nature of the violation, we will have to increase your personal punishment.



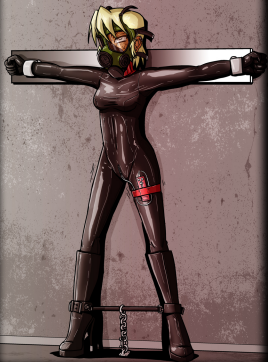
VRRRRooooWWWWWW!!!
